ADDRESS**

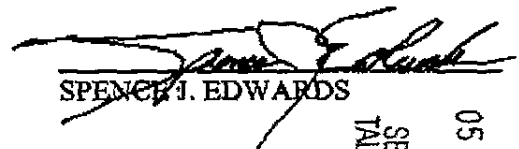
The mailing address and street address of the principal office of the Company shall be 561 Pearl Harbor Drive, Daytona Beach, Florida 32114.
