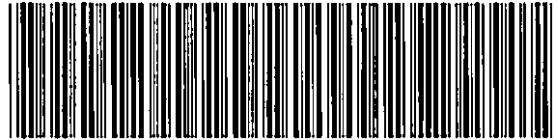

Pursuant to the provisions of Section 605.1025 of the Florida Revised Limited Liability Company Act, BKS D&M HOLDINGS, LLC, a Florida limited liability company ("BKS D&M"), BRP D&M INSURANCE, LLC, a Florida limited liability company ("BRP D&M") and BKS PARTNERS PRIVATE RISK GROUP, LLC, a Florida limited liability company ("BKS PRG," and together with BKS D&M and BRP D&M, the "Merging Companies"), and BALDWIN KRYSTYN SHERMAN PARTNERS, LLC, a Florida limited liability company (the "Surviving Company"), adopt the following Articles of Merger for the purpose of merging the Merging Companies into the Surviving Company (the "Merger").
