ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be CK Investments, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 1601 Ocean Drive South, Unit 303, Jacksonville Beach, Florida 32250.

ARTICLE II

PURPOSES AND POWERS

TERMINATION OF EXISTENCE

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.


ARTICLE VII


