The undersigned, desiring to form a Limited Liability Company under and pursuant to 30 §608.405, Florida Statutes, does hereby certify as follows:

FIRST: The name of said limited liability company shall be **RRN/KCN/Victoria Energy, LLC**.

SECOND: **RRN/KCN/Victoria Energy, LLC** shall exist in perpetuity.

THIRD: Copies of the Operating Agreement of **RRN/KCN/Victoria Energy, LLC** may be obtained from the Manager at **2898 Winding Oak Lane, Wellington, Florida 33414** which is the place in the State of Florida where the principal office of the limited liability company is located. 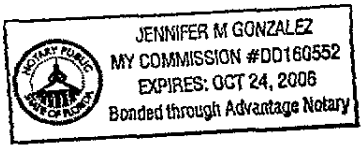
