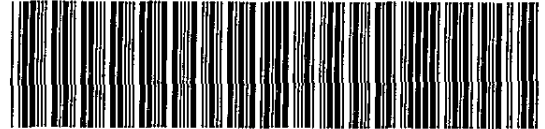



ARTICLE I — Name:

ARTICLE IV — Duration:

The existence of the limited liability company shall be perpetual.

ARTICLE V — Management:

The limited liability company is to be managed by the manager and the name and address of the Managing Member is:

ARTICLE VI— Admission of Additional Members:

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. Pursuant to Section 608.424 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.
