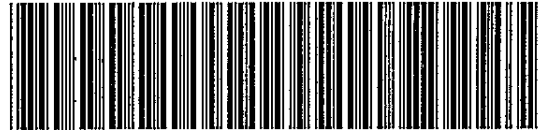

The name of the Limited Liability Company is: J.P. Browning Consulting LLC.




ARTICLE VI - POWERS


