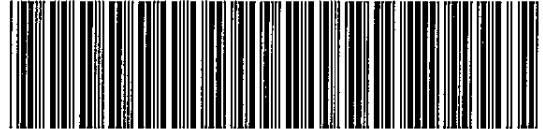


ARTICLE V - Management


