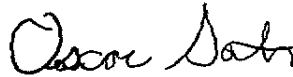

ARTICLE VI-TERMINATION OF EXISTENCE

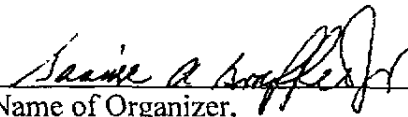
