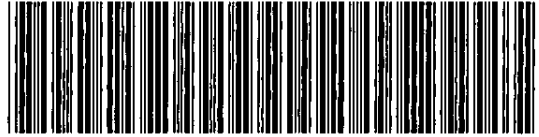

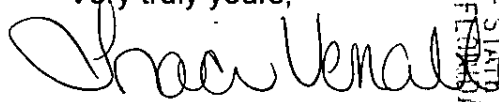

9. Article III of the Articles of Organization states that the Florida registered agent for service of the limited liability company is **Robert Reed** which shall remain the same and in full effect.

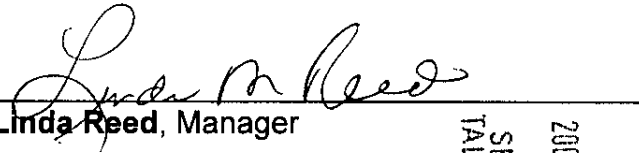
