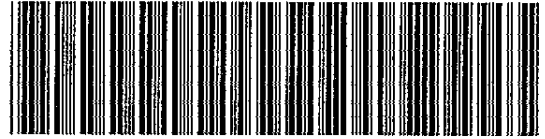



SECOND: The Articles of Organization were filed with the Florida Department of State on January 4, 2006.


