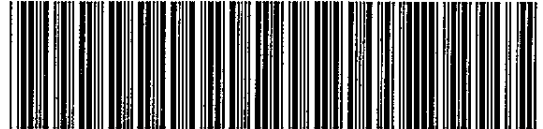

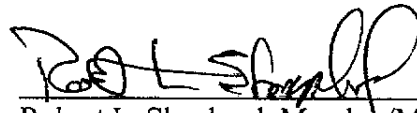

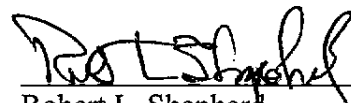
### Title to Company Property
