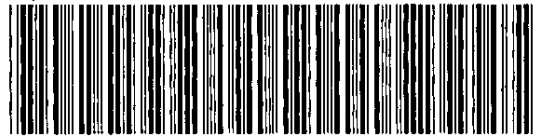



THIRD: The Company is hereby dissolved pursuant to F.S. 608.441 (1)(c), i.e. written consent of all members.


FOURTH: All debts, obligations, and liabilities of the Company have been paid or discharged.
