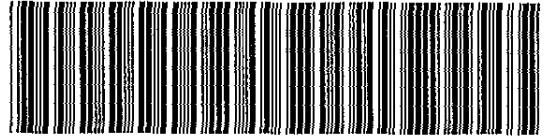

The undersigned, for the purpose of forming a limited liability company under the Florida Professional Limited Liability Company Act, Florida Statutes Chapter 6217, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the professional limited liability company shall be **HIGGINS, MCLAUGHLIN, AND ASSOCIATES, PLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 3949 Evans Avenue, Suite 302, Fort Myers, Florida 33901 and the mailing address shall be the same.

No member of the Company shall enter into any type of agreement vesting another person or entity with the authority to exercise any of a member's voting power in the Company.



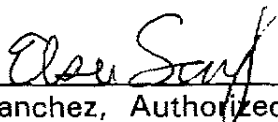
