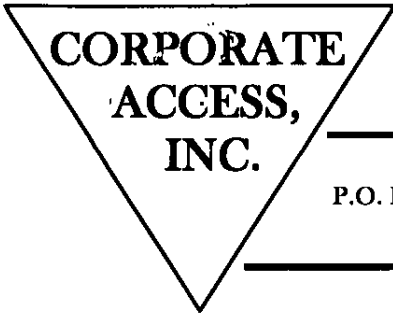

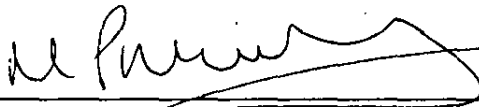
#### ADMISSION OF NEW MEMBERS
