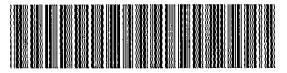

ARTICLES OF ORGANIZATION

ONIC-Maitland Oaks, LLC (A Florida Limited Liability Company)

ation, acting Orlando Neighborhood Improvement Corporation, a Florida not for profit corporation, acting as organizer of a limited liability company under the Limited Liability Company Act of the State 8 Florida, hereby adopts the following Articles of Organization for such limited liability company.

- 1. The name of the limited liability company is ONIC-Maitland Oaks, LLC ("the Company).
- 2. The mailing and street address of the principal office of the Company is: 101 South Terry Avenue, Orlando, Florida, 32805.
- 3. The Company is to be member-managed. The sole and Managing Member is Orlando Neighborhood Improvement Corporation, Inc., a Florida not-for-profit corporation.
- 4. The address of the initial registered office of the Company is John C. Reber, 109 East Church Street, Orlando, Florida 32801.
- 5. The purpose of the Company is to purchase, operate, maintain and preserve that certain apartment complex known as Maitland Oaks Apartments located at 8339 Pembrook Villas Circle, Maitland, Florida.
- 6. The Company may borrow money and pledge all or some of the assets of the Company for the purpose of purchasing, operating, maintaining and preserving the assets of the Company.
- 7. Any action and/or ratification of any prior action duly approved at a meeting of the Board of Directors of Orlando Neighborhood Improvement Corporation in accordance with its Restated Articles of Incorporation and Restated Bylaws, as each are from time to time amended, which applies in whole or in part to ONIC-Maitland Oaks, LLC shall be deemed approval and authorization of such action and/or ratification of such prior action, as the case may be, by the Company.
