ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, being the member of Savoy Realty Group LLC, a Florida limited liability company (the "Company"), hereby amends and restates the Articles of Organization of the Company filed with the Florida Department of State on January 9, 2006, in their entirety to read as follows:

ARTICLE I - NAME
