## ARTICLES OF ORGANIZATION OF EGG HARBOR, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be Egg Harbor, LLC (the "Company").

#### ARTICLE II - ADDRESS

The mailing address of the Company shall be 730 Goodlette Road, North, Suite 100, Naples, Florida 34102. The street address of the initial principal office of the Company shall be 730 Goodlette Road, North, Suite 100, Naples, Florida 34102.

#### ARTICLE III -- DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement

#### ARTICLE IV - REGISTERED OFFICE AND AGENT

#### ARTICLE V - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on such terms and conditions as shall be determined by all the members. The Company shall be dissolved upon the occurrence of events specified in the Company's Operating Agreement.

#### ARTICLE VIII -- MANAGEMENT

The Company shall be managed by the members in accordance with the Operating Agreement adopted by the members for the management of the business and affairs of the Company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.
