**ARTICLES OF ORGANIZATION****OF****COURTHOUSE SHADOWS OFFICE PARK, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

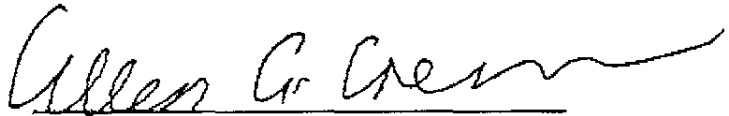
