CONTINUATION AFTER INVOLUNTARY TERMINATION

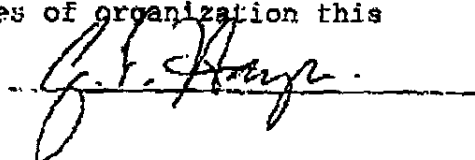
