ARTICLES OF ORGANIZATION

OF

SJ, LLC

The undersigned, being a duly authorized representative of a Member, desiring to forth a limited liability company under and pursuant to the Florida Limited Liability Company Act, chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization and hereby certifies:

ARTICLE I: NAME

The name of the limited liability company is SJ, LLC (the "Limited Liability Company").

ARTICLE II: ADDRESSES

ARTICLE V: REGISTERED AGENT AND OFFICE

ARTICLE VI: ADDITIONAL MEMBERS

Such Manager shall serve in such capacity until the first annual meeting of the Members or until his successor is duly elected and qualified.

ARTICLE VIII: REGULATIONS

The power to adopt, alter, amend or repeal the Regulations of the Limited Liability Company shall be initially vested in the Members of the Limited Liability Company and thereafter in the manner prescribed by and provided in any adopted Regulations of the Limited Liability Company.

ARTICLE IX: LIMITATION ON AGENCY AUTHORITY OF MEMBERS
