#### ARTICLES OF ORGANIZATION

#### **OF**

### ELKTON GREEN, LLC

In accordance with the provisions of the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, (the "Act") the undersigned, sole organizer of a Florida limited liability company, and an authorized representative of a Member of the Company hereby files these Articles of Organization:

#### ARTICLE I -- NAME

The name of the limited liability company is ELKTON GREEN, LLC (the "Company").

#### ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company in the State of Florida is 3020 Hartley Road, Suite 100, Jacksonville, Duval County, Florida 32257.

#### ARTICLE III -- REGISTERED AGENT & OFFICE
