### ARTICLES OF ORGANIZATION

OF

#### RP PROPERTIES, L.L.C..

The undersigned, JAMES RAY BROWNLEE, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

## ARTICLE I -- NAME
