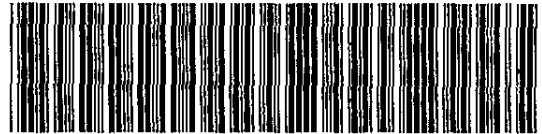

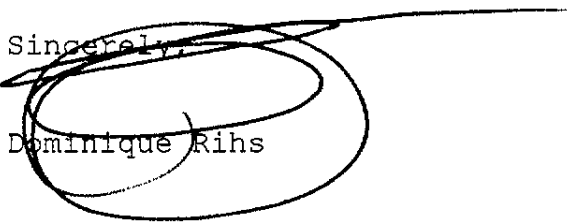

**ARTICLES OF ORGANIZATION FOR

A FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I- NAME:

The name of the Limited Liability Company is: **Must Be The Money, L.L.C.**

ARTICLE- VI Admission of Additional Members:

Additional members shall be admitted to the Company upon the approval of all then-existing members of the Company & upon such terms & conditions of admission as shall be established by agreement of all then-existing members of the Company.

ARTICLE- VII Members Rights to Continue Business:

The limited liability company shall have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company if all the remaining members consent to the continuance of the Company's business notwithstanding the death, insanity, bankruptcy, retirement, resignation, expulsion or dissolution of any member. Further, the Company shall be dissolved upon unanimous agreement of all members or upon there being no member due to death, insanity, bankruptcy, retirement, resignation, expulsion or dissolution of a member.

ARTICLE- VIII Initial Capitalization:

The Company's initial capitalization shall be \$ 5,000.00. Members agree to make any additional contribution of capital to the Company at such future time as needed and approved by the members.

ARTICLE- IX Membership & Operating Agreement:

The management of the Company shall be reserved to the members & the respective duties & authorities of each of the members shall be as set forth in their Membership & Operating Agreement, which includes the right to convey, purchase and mortgage real property.
