## ARTICLES OF ORGANIZATION OF GUARANTY TRUST AND TITLE OF COCONUT CREEK, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act., F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization

#### ARTICLE 1 - NAME

The name of the Limited Liability company shall be GUARANTY TRUST AND TITLE OF COCONUT CREEK, L.L.C.

#### ARTICLE II - ADDRESS
