**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I
NAME AND ADDRESS**

MANAGEMENT (MANAGEMENT BY MEMBERS)**


The Company shall be managed by its Members, in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These


