**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF MICHIGAN COURT DEVELOPMENT COMPANY I, LLC**

THE UNDERSIGNED hereby makes and files with the Secretary of State of the State of Florida, this Amended and Restated Articles of Organization for the purpose of amending and restating the Articles of Organization filed January 12, 2006 under Document Number L06000004531, as follows:

1. **NAME.** The name of this limited liability company is **RENAISSANCE PRESERVE I, LLC** (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.

2. **DURATION.** The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. **PURPOSE.** The Company is organized for the purpose of transacting all lawful activities and business that may be conducted by a limited liability company under the laws of the State of Florida.

4. **PLACE OF BUSINESS.** The mailing address and street address of the Company's principal office is 4224 Michigan Avenue, Fort Myers, Florida 33916.


