**Articles of Organization
of
ALTERATIONS, COUTURE & REPAIRS LLC**

THESE ARTICLES OF ORGANIZATION forming a limited liability company under the laws of the State of Florida are made and executed this 18th day of November 2005, by the undersigned.


1. **Name, Mailing Address and Principal Address.** The name of the limited liability company is Alterations, Couture & Repairs LLC (hereinafter referred to as the "Company"). The mailing address and street address of the principal place of business of the Company shall be: 10009 Cleary Blvd, Plantation, Florida 33324.

2. **Term.** The term or period of duration of the Company shall commence on the date of the filing of these Articles of Organization with the Florida Division of Corporations and Commercial Code and shall continue for a term of twenty (20) years from that date, unless sooner terminated pursuant to law or the provisions of the Company's Operating Agreement.

3. **Business Purpose.** The character and purposes of the Company and its business are (1) to engage in any lawful act or activity for which companies may be organized under the State of Florida; (2) to do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers herein set forth, either alone or in association with others, and incidental or pertaining to, or growing out of, or connected with, its business or powers, provided the same is consistent with the laws of the State of Florida.

4. **Registered Office and Agent.** The street address of the Company's registered office is 1570 Madruga Avenue, Suite 415, Coral Gables, Florida 33136. The name of the Company's initial registered agent at that address is Ricardo Ramirez.

5. **Substitute Service of Process.** The Florida Division of Corporations is hereby appointed as the agent of the Company for service of process if the registered

agent has resigned, the registered agent's authority has been revoked, or the registered agent cannot be found or served with the exercise of reasonable diligence.

6. **Management.** The management of the company shall be vested in the Managers and a majority of the Managers voting shall be necessary for all decisions affecting the Company. The Managers shall serve until their successors are appointed or until their resignation or removal. The initial Manager of the company and the address is as follows:

7. **Members.** This company will have one (1) or more Members upon formation and will always maintain at least one (1) Member. New Members may be added to the Company only with the unanimous consent of all the existing Members. If a Member sells or assigns an interest in the Company, the purchaser or assignee is entitled to all of the financial rights of the selling or assigning Member in the Company. The purchaser or assignee is not permitted to participate in the management of the Company without the unanimous consent of the non-selling Members. The Organizing Members of the Company and their addresses are as follows:

As provided in the Company's Operating Agreement, certain powers are vested solely in the Members, acting unanimously, and in the event all Managers resign or are removed from office as provided in the Company's Operating Agreement, the business of the Company shall be under the exclusive management of the Members, acting unanimously.

8. **Continuation of Business.** Under the terms of the operating agreement, the Members may not continue the business without dissolution upon the death, expulsion, resignation, or withdrawal of a Member from the Company without the consent of all of the remaining Members.

9. **Tax Treatment.** The Members intend that this company will for federal tax purposes be treated as an corporation.
