ARTICLE VIII: PURPOSE

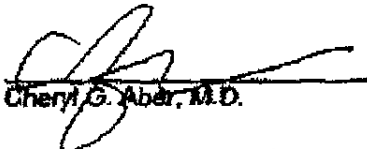
The Company shall be formed for the purpose of providing medical and related services and such other businesses as may be conducted by professional limited liability companies pursuant to Florida law.
