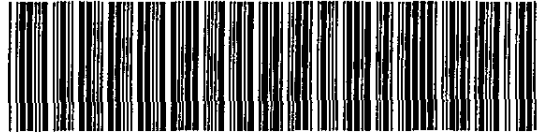

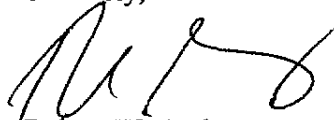

The rights and obligations of the Manager shall be governed by the provisions of Chapter 608, Florida Statutes, and as set forth in the Operating Agreement.

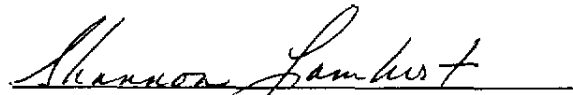
ARTICLE VI - Admission of Additional Members:

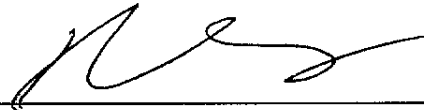
