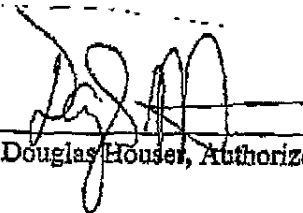
1. NAME. The name of the Limited Liability Company is ADVANCED MOBILE TECHNOLOGY, LLC (the "Company").
