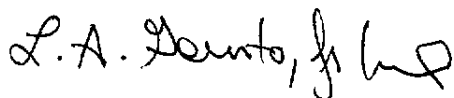

ARTICLES OF ORGANIZATION
of
710 OLD DIXIE, LLC
A Florida Limited Liability Company

ARTICLE 1
NAME

The name of this limited liability company is 710 Old Dixie, LLC.

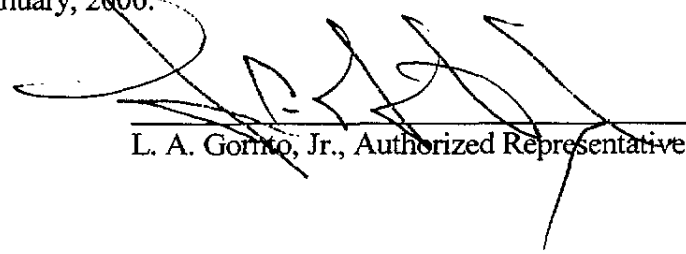

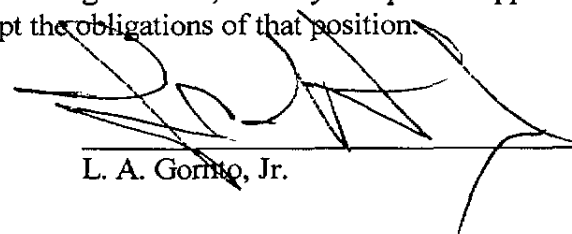
