The mailing and street address of the principal office of the Company is 101 Caspian Cove, Sanford, FL 32773.

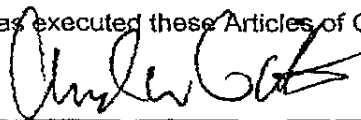
ARTICLE III - REGISTERED AGENT AND OFFICE
