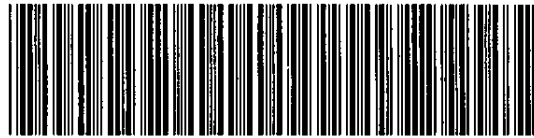

ARTICLES OF DISSOLUTION OF RSSJM, LLC

RSSJM, LLC, a Florida limited liability company, pursuant to §§ 608.445 and 608.446, Fla. Stat., files these its Articles of Dissolution and states:

1. The name of the limited liability company is RSSJM, LLC.
2. The Articles of Organization were filed on January 12, 2006, and assigned document number L06000005956.
3. The dissolution of the limited liability company was approved by the members on September 23, 2008.
4. The effective date of the limited liability company's dissolution is to be October 20, 2008.
5. The occurrence that resulted in the limited liability company's dissolution pursuant to § 608.441(c), Fla. Stat., is that pursuant to the operating agreement members holding a majority of the membership units of the limited liability company approved the limited liability company's dissolution and consented in writing to the limited liability company's dissolution. 


