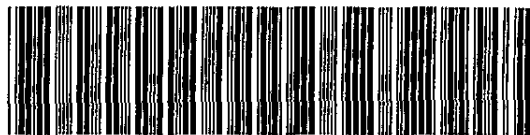

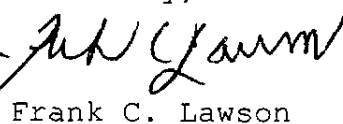

The Limited Liability Company may admit additional members at any time and in any manner by the unanimous (majority) written (or oral) consent of the members.

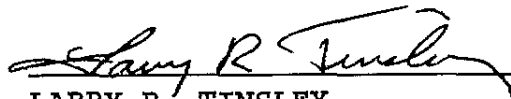
ARTICLE XI. AMENDMENT
