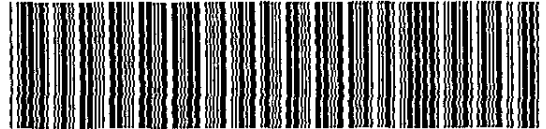

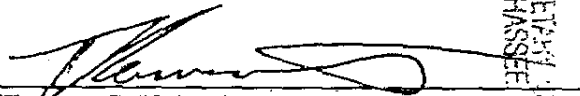
## ARTICLE VIII – AMENDMENT TO ARTICLES OF ORGANIZATION
