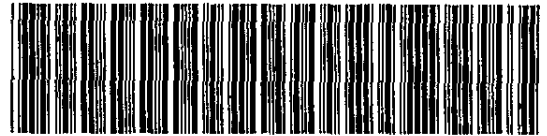

**ARTICLE IX**

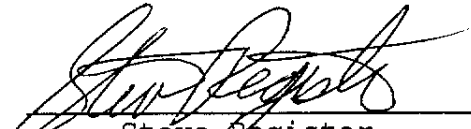
The members may agree in writing to an Operating Agreement, which said agreement may from time to time be repealed, amended or altered by an instrument in writing.

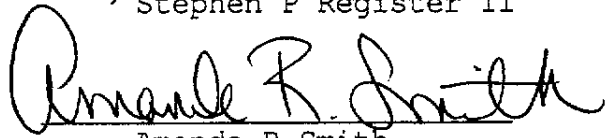
