**Article I
Name**

The name of the limited liability company ("Company") is Granville Boat Works, LLC.

**Article II
Address**


**Article VII
Admission of New Members**

Members of the Company have the right to admit new members. Members may admit to the Company additional members to participate in the profits, losses, available cash flow, and ownership of the assets of the Company on such terms as are determined by all of the members. Admission of any such additional members requires the written consent of all members then having any ownership interest in the Company. Any additional members are allocated gain, loss, income or expense by the method provided in the Company's operating agreement, and if no method is specified, then as may be permitted by the Internal Revenue Code of 1986, as amended.


**Article VIII
