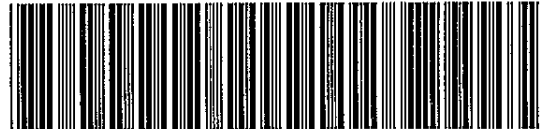

The undersigned, **RANDY B. POWELL, M.D.**, as the subscribers to these Articles of Organization hereby present these Articles for the formation of a limited liability company under the provisions of Florida Statutes Chapter 608.

**ARTICLE I.
NAME OF LIMITED LIABILITY COMPANY**


