

### ARTICLES OF ORGANIZATION

STATE OF THE STATE The undersigned person, acting as the organizer of a limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608), hereby adopts the following Articles of Organization;

- Name. The name of this limited liability company is "CAVALIER INVESTMENTS, 1. L.L.C." ("Company").

The members have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or occurrence of any other event which terminates the continued membership of a member in the Company. Continuation may occur only pursuant to the terms of the Operating Agreement and with the unanimous vote of the members.
