

**AMENDMENT TO THE
ARTICLES OF ORGANIZATION
OF
HOWELL PARK GROUP, LLC**

Pursuant to Section 608.411, Florida Statutes, the Articles of Organization of the above named Limited Liability Company are amended as follows:

1. The purpose of the Limited Liability Company shall be the following: The purpose and scope of the Company shall be to engage in the business of such activities as are approved by the Member and to engage in any lawful act or activities necessary or incidental thereto, so long as the Company shall not carry on any activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Service, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Service, or the corresponding section of any future federal tax code.

The foregoing amendment was approved by the sole Member of the Limited Liability Company on the 19th day of March, 2007.
