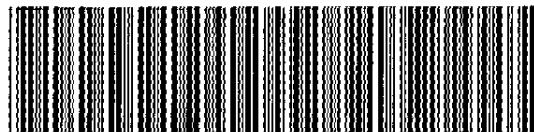

KINGSTON ENTERPRISES, LLC




