**ARTICLES OF ORGANIZATION
OF
TANGO DASH, LLC**

The undersigned authorized representative of a member of the captioned Limited Liability Company, under the provisions of the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I

Name, Addresses and Purpose of Organization

The name of this limited liability company is Tango Dash, LLC (the "Company"). The Company's initial mailing address is P.O. Box 1559, Stuart, FL 34995-1559 and its street address is 333 Tressler Drive, Suite B, Stuart, Florida 34994. The Company's initial registered agent is David M. The Company is organized to enable its members to transact any lawful business for which a limited liability company may be organized under Florida law.


