AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF New Age LLC

The undersigned, for the purpose of forming a limited liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I- NAME

The name of the Limited Liability Company is New Age LLC.

ARTICLE II- ADDRESS

ARTICLE III- DURATION

ARTICLE VI- CAPITAL CONTRIBUTIONS
