ARTICLE I - Name

The name of the limited liability company is: **BENT TREE HOLDINGS, LLC**

ARTICLE II - Address

The initial mailing address and street address of the principal office of the limited liability company is 24 South Orange Avenue, Orlando, FL 32801.

ARTICLE III - Duration

The Company shall be dissolved and its affairs wound up in accordance with the Florida Limited Liability Company Act (the "Act") and the Company's Operating Agreement on December 31, 2056, unless the term shall be extended by amendment to the Company's Operating Agreement and this Certificate, or unless the Company shall be sooner dissolved and its affairs wound up in accordance with the Act or the Company's Operating Agreement.

The Company reserves the right to amend, alter, change or repeal any provision contained in these Articles of Organization in the manner now or hereafter prescribed by the Act
