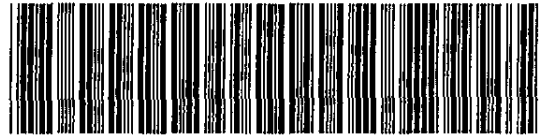

ARTICLE III - MANAGEMENT



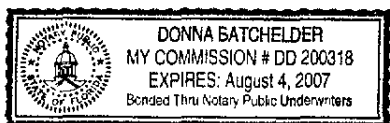


