ARTICLES OF ORGANIZATION OF MARJO PROPERTIES, LLC, a Florida Limited Liability Company

ARTICLE I NAME

The name of this Limited Liability Company (this "Company") shall be **MARJO PROPERTIES, LLC**, and its principal place of business and mailing address shall be 7726 Pine Vista Court, Orlando, Florida 32819.

ARTICLE II COMMENCE OF CORPORATE EXISTENCE
