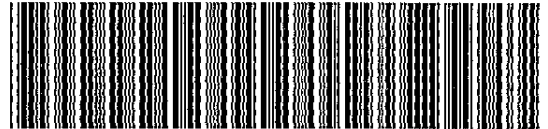

ARTICLES OF ORGANIZATION
OF ENVIRONMENTAL PEST CONTROL, LLC.
a Florida limited liability company

ARTICLE I

NAME

The name of this limited liability company is ENVIRONMENTAL PEST CONTROL, LLC.

ARTICLE II

PURPOSE

These Articles may be amended at any time by a resolution adopted by the members, in conformity with the regulations permitting said amendment, at any annual or special meeting.


ARTICLE XI


