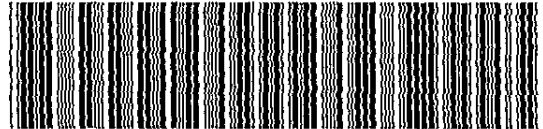



Management




