**ARTICLES OF ORGANIZATION**

**Company Name and Principal Office**

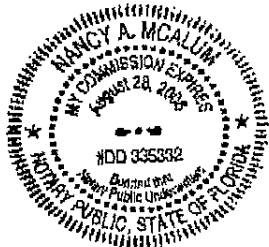
