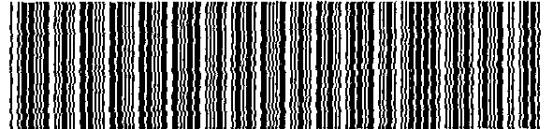

FIRST: The name of the limited liability company is BBL West Melbourne, LLC (the "Company").

SECOND: The mailing address and street address of the principal office of the Company is 302 Washington Avenue Extension, Albany, New York 12203.

FIFTH: The Company is to be managed by one or more managers or a class or classes of managers.
